<b>Sl. No.</b>	<b>GENERAL CONDITIONS - The school is directed to ensure that :</b>
1.	The total number of section of the school shall be restricted to 12 (As per prescribed dimension) as per the number of class rooms reported during inspection and further increase shall be subjected to specific approval of the Board on the basis of the request of the school as per affiliation bye laws.
2.	Compliance of the points no. 1 to 8 may be submitted within 03 months on the SARAS Portal, failing which due action will be taken.
<b>Sl. No.</b>	<b>CONDITIONS FOR COMPLIANCE</b>
1	1. The total number of sections of the school shall be restricted to 12 and further increase shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye laws subject to availability of class rooms of dimensions>500ft.
2	2. The school has a ramp outside the entrance, without a hand rail.A temporary wooden wedge is place at the entry of the school building which is dangerous for students and not as per norms.There is no ramp/lift for CWSN to access the upper floors.The school shall affix a hand rail on the ramp outside the entrance, construct a permanent ramp at the entry of the building and construct a ramp/install a lift for accessing upper floors within 3 months and submit compliance on SARAS.
3	3. The school has converted regular cubicles into CWSN washrooms, which are very small and have no room for a wheelchair/walker to move in.Only 1 each at the ground floor are seen.The school shall construct separate toilets for CWSN,boys and girls on every floor, with proper permanent signage, indicating the floor number, as per norms of RPwD Act and guidelines issued by the Board within 3 months and submit compliance on SARAS.
4	4. The composite science lab needs more work stations and equipment and proper seating and storage area. The library needs to be better stocked and separate reading area should be made for staff. The school shall upgrade its composite science lab and library as per SoPs of the Board within 3 months and submit compliance on SARAS.
5	5. Failure to submit compliance on the above mentioned points within prescribed time shall invite financial penalty against the school.
6	6. The school shall not remove the videography links in the mandatory disclosure section of its website and renew all mandatory certificates from time to time.



7	7. The school shall conduct training of its teachers with CoE Bengaluru within 3 months and submit the compliance.
8	8. The school shall follow the SoPs issued by the Board in respect of labs, library and sports facilities.

The above is subject to fulfillment of the following conditions:-

1. The approval is based upon the documents /data/information uploaded by the school online. The school will be responsible for its genuineness. In case of any discrepancies, necessary action will be initiated against the school as per Affiliation Bye -Laws-2018.
